Sweden India Business council

The Sweden India Business Council (SIBC) is the business network organisation between the Swedish and Indian business community. Our main objective is to enhance our member's knowledge of how to access the Swedish and Indian markets. We do this through a variety of interesting gatherings in order to facilitate networking.
